
1. Final outcome of the notification of MoUD, GOI.

6. That the school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the Department from time to time.


7. That the school shall comply with the order/guidelines of DoE and judicial pronouncement w.r.t utilization/maintenance of school funds.
